Distributorship fee to the company by way of a crossed demand draft.

- The applicant should have completed minimum 18 years of age and shall be competent enter into contract as provide in the 'Indian Contracts Act.
- For joining as an independent distributor of the company, then the applicant will have to make the prescribed payment towards distributorship fee by way of a crossed demand draft favoring CLIC payable at Mumbai.
